New Expanded FinCEN Geographic Targeting Order Effective October 22, 2023; New Jurisdictions Effective November 21, 2023

Doma Title Insurance, Inc. (Doma) continues to support our agents by assisting them in meeting the filing requirements of the newly issued Geographic Targeting Order (GTO), issued on April 21, 2023, by the Director of the Financial Crimes Enforcement Network of the U.S. Treasury Department (FinCEN).

The term of the new FinCEN GTO for jurisdictions already covered by an earlier GTO is **October 22, 2023 to April 18, 2024**.

Additionally, the term of the GTO with regard to the newly added Texas county of Travis; the Massachusetts counties of Bristol, Essex, Norfolk, and Plymouth; and the Florida counties of Hillsborough, Pasco, Pinellas, Manatee, Sarasota, Charlotte, Lee, and Collier is **November 21, 2023 to April 18, 2024**.

A copy of the new GTO is attached for your review.

I. The GTO Effective Dates: New Jurisdictions

The current GTO is another 180-day order. It runs from **October 22, 2023 to April 18, 2024**. This timeframe applies to all counties which were impacted by an earlier GTO order.

This new GTO has also expanded its coverage area to include the jurisdictions of Texas county of Travis; the Massachusetts counties of Bristol, Essex, Norfolk, and Plymouth; and the Florida counties of Hillsborough, Pasco, Pinellas, Manatee, Sarasota, Charlotte, Lee, and Collier. For these newly impacted areas, the GTO is effective from **November 21, 2023 to April 18, 2024**.

With these new coverage areas, the chart below reflects all impacted counties, cities and jurisdictions which are subject to the new GTO:

*If the purchase price of the residential real property is in the amount **of \$50,000 or more in the city or county of Baltimore in Maryland,** it will be a Covered Transaction under the GTO.

**The cities of Alexandria, Falls Church and Fairfax, Virginia, are covered as well.

The GTO maintains a uniform purchase price of **\$300,000** for reporting a transaction in all other affected cities, counties and jurisdictions, exclusive of Baltimore City and Baltimore County, Maryland.

A "Covered Transaction" under the new GTO continues to mean a transaction in which:

i. Residential real property is purchased by a Legal Entity (as this term is defined in Section III.A of the GTO);

ii. The purchase price of the residential real property is in the amount of \$50,000 or more in the city or county of Baltimore in Maryland, or in the amount of \$300,000 or more in any of the other areas listed in Section I above;

iii. Such purchase is made without a bank loan or other similar form of external financing; and

iv. Such purchase is made, at least in part, using currency or a cashier's check, a certified check, a traveler's check, a personal check, a business check, a money order in any form, a funds transfer or virtual currency.
